

**SNICKERS Bryce Cream Bar Sweepstakes  
Official Rules**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**VOID IN ALASKA, HAWAII AND WHERE PROHIBITED OR RESTRICTED BY LAW.**

The SNICKERS Bryce Cream Bar Sweepstakes (the "Sweepstakes") starts on April 25, 2023 at 8am Eastern Time ("ET") and ends on May 1, 2023 at 11:59pm ET (the "Sweepstakes Period").

**ELIGIBILITY:** Sweepstakes is open to legal residents of the forty-eight (48) contiguous United States and the District of Columbia who are eighteen (18) years of age or older. Employees of Mars Wrigley Confectionery US, LLC ("Sponsor"), Weber Shandwick ("Administrator"), and their respective parents, subsidiaries, affiliates and their promotion and advertising agencies, and members of their immediate family (spouse and parent, children and siblings and their respective spouses, regardless of where they reside) and persons living in the same household, whether or not related, of such employees, are not eligible to enter or win. Sweepstakes is void in Alaska, Hawaii and where prohibited and is subject to all applicable federal, state and local laws.

**HOW TO ENTER:** During the Sweepstakes Period, visit [snickers.com/BryceCreamBar](https://snickers.com/BryceCreamBar) and follow the instructions to complete and submit the online entry form to receive one (1) entry into the Sweepstakes. Entries must be received by Administrator by May 1, 2023 at 11:59pm ET in order to be eligible.

Limit of one (1) entry per person using only one (1) email address throughout the Sweepstakes Period. Entries received from any person or email address in excess of the stated limitation will be void. Entries generated by script, macro, or other automated means and entries made by any means or practices which subvert the entry process are void. All entries become the property of Sponsor.

**RANDOM DRAWING/ODDS:** On or about May 2, 2023, Administrator will select three hundred and fifty (350) potential winners in a random drawing from among all eligible entries received. Odds of winning a prize depend on the number of eligible entries received throughout the Sweepstakes Period.

**WINNER NOTIFICATION:** Potential winners will be notified by e-mail. If any prize or prize notification is returned as undeliverable, Sponsor or Administrator is unable to contact a potential winner or a potential winner is not in compliance with these Official Rules, prize will be forfeited and, at Sponsor's discretion, an alternate winner may be selected. If a potential winner is an eligible minor in their jurisdiction of residence, prize may be awarded in the name of their parent or legal guardian who will be responsible for fulfilling all requirements imposed on winner set forth herein. Sponsor/Administrator, in their sole discretion, will attempt to contact up to two (2) potential winners of a prize in accordance with the above procedure, after which the prize in question may go unawarded if it remains unclaimed.

Winners may not substitute, assign or transfer prize or redeem prize for cash, but Sponsor reserves the right, at its sole discretion, to substitute prize (or portion thereof) with one of comparable or greater value. Released Parties are also not responsible for any incorrect or inaccurate information, whether caused by site users, tampering, hacking, or by any equipment or programming associated with or utilized in the Sweepstakes. Released Parties are not responsible for injury or damage to any person's computer related to or resulting from participating in this Sweepstakes or downloading materials from or use of the website. its sole discretion to suspend, modify or terminate the Sweepstakes (or portion thereof) and, if terminated, at its discretion, select the potential winners from among all non-suspect, eligible entries received prior to action taken.
